PRESIDENT'S **MESSAGE**

The ATS Board of Directors has been busy the past few weeks having their committee meetings in preparation for our next Board meeting. The Strategic Planning Committee, chaired by Third Vice-President, Monica Weber reviewed and updated our Risk Assessment and Management document which is filed with the Ohio Insurance Department. The strategic risk management is the process of identifying, quantifying and mitigating any risk that affects or is inherent to our company's business strategy, strategic objectives and strategic execution. The Board regularly updates and reviews the assessments based on new developments or actions that the ATS has taken.

Following that meeting, a Cultural Promotion Committee meeting was held also chaired by Monica Weber. The Committee reviewed the past year activities and discussed ideas to promote cultural activities in each Local Branch. The committee plans to have face to face meetings with **Local Branch officers and interested members to** discuss ideas to promote cultural events or the possibility of forming a cultural group.

The Investment and Insurance Sales Committee, co-chaired by Treasurer Denise Crawford and First Vice-President Robert Cunningham, had their quarterly conference call with our Investment Counselor, John McPike to review our recent transactions and the next few months investment strategy. Emphasis was placed on the effect of 2017 Tax Reform Act on our Risk-Based Capital ratio and how we will alleviate any negative effect to this ratio. We also discussed the economic and investment forecast for the end of this year and first part of 2019.

The IT Committee, chaired by Robert Cunningham, met with CRU Solutions, our IT business and security consultants that service our computer systems, to secure our business data. He reviewed our operating system where security patches are constantly being installed as needed. Our system is backed-up hourly and replications are documented and time stamped. He recommended a new security measure to protect our data from the Dark Web. Our overall health of the ATS computer network is good and everything has been operating as it should.

I am so grateful to work with my fellow officers that are dedicated to secure the future of our fraternal organization.

Transylvanian Saxon Trivia: In the medieval times, magnificence was importance to our Saxon people in showing the richness of their city or village. There

was competition of "which Saxon church had the highest tower." So is a tale that takes us to Hermannstadt and Bistritz, two lovely cities with very proud citizens. In Hermannstadt, when the citadel's church was erected, the locals thought about building a marvelous tower, the highest in Transylvania, the only problem being that Bistritz already had the highest church tower. So, the tale goes, two locals from Hermannstadt were sent to measure it with a rope, in the middle of the night. Once the work was done, they started back home and, in the evening, they stopped at an inn. After having too many glasses of wine, they talked of their mission of getting the measurements of Bistritz church tower which was overheard by some Saxons from Bistritz. So, while sleeping, the locals from Bistritz cut two meters from the rope. When building the tower in Hermannstadt which they wanted to be slightly higher than the tower of Bistritz, they found out that their strategy did not work as they intended and Bistritz church tower remained the tallest in Transylvania at that time!

Calorie information in restaurants helps curb eating

A new study carried out by the National Bureau of Economic Research has shown that diners tend to order food with about 3 percent fewer calories when the nutritional information is listed on their menus.

According to Healthline, a recent law passed by the Food and Drug Administration means that restaurants and grocery stores that have at least 20 locations will be required to list this calorie information for standard menu items. This is part of a strategy to help reduce the obesity epidemic in America which now affects almost 70 percent of adults.

In the Bureau study, participants overwhelmingly commented that they valued having the information listed on the menu. For example, a regular fried chicken sandwich from Chick-Fil-A has 440 calories while the grilled version has only 310. A consumer interested in reducing calories can save 30 percent just by switching one menu item.

Restaurants in the study saw no difference in their revenue, profits, or labor expenditures when they included the calorie counts on the menus.

The study also found that even the chefs themselves were surprised by the number of calories in their food.

Tax moves to make before year-end

As April's tax deadline looms, there are some things you can do before Dec. 31 to cut your tax bill.

First, use any extra money to make a final contribution to an IRA or 401k. This makes a tidy deduction in taxable income. In 2018, those limits are \$5,500 and \$18,500, respectively.

Don't forget that unused money in a flexible medical spending account will be lost at the end of the year so use the balance to stock up on eligible household items like bandages, vitamins, and sunscreens.

Homeowners that plan to itemize their deductions should think about squeezing in an extra mortgage payment at the end of the year, something that adds to a deduction and pays your house off sooner.

One significant change in the 2018 tax code caps the deduction for state and local taxes (SALT) at \$10,000 for any combination of proper-

ty, income, or sales-related taxes. those For with expensive homes high propertytax states, this can be a hit. For

example, New York's aver-\$21,000. The deduction cap won't affect the average homeowner outside coastal and metro areas.

Many people can gain age deduction last year was a small advantage in their taxes by selling investments December 4, 2018 @ 1:00 that lost money during the year and using the losses to offset capital gains on a dollar-per-dollar basis, up to \$3,000, on the ones that did well. Extra losses can also be carried over to future tax years, meaning one particularly lousy year can spread out over time.

Additionally, donating cash to charity is deductible, but it is important to remember that unwanted items can be given and written off at current fair market value as well.



Cranberry orange baked french toast casserole



Cranberries and oranges have long been a part of many family Christmas traditions and they are still a fun way to inject a little history into the celebration.

According to The Kitchen, for instance, oranges have been used as special treats for centuries. Great-grand-parents today might be able to tell stories of the Great Depression and the incredible gift of sweet oranges on Christmas Day.

According to Colonial Williamsburg, meanwhile, cranberries were often used during the holidays because their bright red color was

the perfect addition to decorations. It was common to see them strung alongside popcorn on Christmas trees. Slow to spoil, cranberries keep well throughout the winter season and will likely be available for many holiday treats.

Here is a recipe, courtesy of the Taste and Tell blog, that incorporates both oranges and cranberries into a delicious breakfast casserole that is perfect to make ahead. Pop it in the oven on Christmas morning to avoid the hassle of extra prep on a day already full of festivities and activity.

Ingredients

1 cup fresh cranberries, divided
1 (1 lb) loaf white bread, cut into 1-inch cubes
2 cups milk
6 eggs, lightly beaten
1 tablespoon orange zest
1 teaspoon vanilla extract
1/2 teaspoon cinnamon
1/2 teaspoon orange extract
powdered sugar, for serving

1/4 cup butter, melted

1 cup light brown sugar

Directions

- 1. Pour the melted butter evenly into the bottom of a 9x13-inch baking dish. Sprinkle the brown sugar evenly over the top. Sprinkle 1/2 cup of the cranberries over the top of the brown sugar. Add the cubed bread to the baking dish. Sprinkle the remaining cranberries over the top.
- 2. In a large bowl, combine the milk, eggs, orange zest, vanilla extract, cinnamon, and orange extract (if using), and beat lightly to combine. Pour the mixture evenly over the top of the bread in the baking dish. Press the bread down into the liquid mixture if needed to make sure all of the bread is soaked. Cover the dish with foil and refrigerate overnight, at least 8 hours.
- 3. Bring the dish out of the refrigerator 30 minutes before baking. Preheat the oven to 375 degrees F. Bake the casserole, still covered, for 30 minutes. Remove the foil and continue baking until the top is browned and a tester inserted in the center comes out clean, another 15-20 minutes.
- 4. Let the casserole sit for 10 minutes before serving. Serve topped with powdered sugar.





Mid-winter horns herald Christmas

On a chilly December morning, you might hear them: the mid-winter horns lonely blowing notes over the woods and countrysides of the Netherlands. It's a tradition buried deep in folk history and one that survives still along the eastern



The mid-winter horns are a tradition passed from father to son -- and by no means an easy one. The horns are made from curved elder branches, cut lengthwise and hollowed out. They are then reattached to form a meter-long wooden horn -- difficult to sound and harder still to make any kind of music.

Although some experienced horn blowers can blow a melody of about eight notes from the horns, music really isn't the point.



Actually, the point is kind of buried in folk traditions. Some say the ancients thought time stopped in the winter and the horns brought promise that the sun would come again. At other times, the horns have been used for communication. In times of war, farmers might sound the horn to alert others to enemy advance. Smugglers even used horns to alert compatriots of the police.

But, today, the horns herald the coming of Christmas, from Advent to Dec. 26.
