Since 1960 Schloss Horneck has housed the Siebenbürg-Museum, the Siebenbürger Library and Archive, the Siebenbürger-Institut and is the base for many Saxon organizations. A seniors home is also located on the property. Last September the Verband der Siebenbürger Sachsen in Deutschland purchased the property for one million Euro.

Transylvanian Saxon Trivia: Rosenau fortress had its shares of sieges, heroic fights and medieval confrontations. The fortress is located on a rocky hill surrounded by forests that were once hard to cross. It was originally built on the ruins of an ancient site by the Teutonic Knights between 1211 -1225. In 1335 it survived the Tartar invasion that destroyed the area of Kronstadt. The Transylvanian Saxons later enlarged and fortified the fortress. Due to the prolonged and often attacks, the Saxons built a small town inside the walls. In total 80 houses were discovered by archaeologists. The construction

was done in several stages, and over time defensive methods used were cannons and artillery weapons. In 1612 Gabriel Bathory (Hungarian, Prince of Transylvania from 1608-1613) conquered the fortress and was recovered by the Saxon community only after paying a consistent ransom. The small town was abandoned inside the fortress at the beginning of the 18th century when the southern Carpathian border was secured under the domination of the Habsburg Empire. Today, the fortress is one of the largest and most remarkable medieval monuments in Transylvania and is a wonderful historical attraction to visit when in the Kronstadt area.





#### What is a financial caregiver?

#### The Foundation, a Solid Basis for our "Castle of Books"

The storage of precious items always entails a certain cost and effort, especially when the items may be damaged by environmental influences and also by users. This certainly applies to our "national library's" holdings. For the above reasons it is absolutely vital that a qualified professional staff is hired. Moreover administrative, rent and ancillary expenses need to be covered. So far the Transylvanian Library Foundation is not yet in the position to completely meet these costs. Large gaps remain in the budget for staff, rent and ancillary expenses.

Besides the roughly one thousand donors who participate in building the Foundation's assets with both smaller and larger, one-off as well as multiple sums, the subfoundations have also been contributing a roughly equal share. At present the following twelve subfoundations help to support us: Dr. Ortrud and Dipl.-Ing. Gerhardt Graeser; Dr. Roswitha and Martin Guist; Elfriede and Balduin Herter; Ute Sieglinde Hien; Gerlinde and Harro Hubbes, Dagmar Heuchert; Dipl.-Ing. Alfred Kasper, Sächsisch Reen, and wife Marga, Freiberg/Sachsen; Meta and Ingo Phleps; Heide Roth; Studium Transylvanicum; Hildegard and Günter Volkmer; Hedwig Waadt, nee König; Johanna and Dr. Arnold Weingärtner.

The founders of these subfoundations wanted to use their good names and their donations (minimum of 10,000 Euros) to promote both the Foundation's success and the creation of further subfoundations, because they are convinced that the artefacts stored in Gundelsheim that bear witness to our history and culture are of vital importance.

Some of these subfoundations were created on the basis of a donation, a legacy or a testament. In this context it is important for potential testators to formulate their dispositions precisely, particularly when there are multiple heirs or beneficiaries. The testator's last will must be explicitly evident in order to prevent subsequent disputes and to clearly identify the beneficiaries. Of the three possibilities mentioned

above, a donation is the most advantageous to the Foundation. On the one hand, donations do not involve trips to the authorities with the associated expenses and on the other hand the capital can more rapidly be put to use for the Foundation. The donor benefits from the fact that the donation, spread out over several years, is deductible from income tax and also from the knowledge that his or her good deed is accomplished more swiftly.

The Foundation is an institution that in principle should exist in perpetuity. It will only be able to achieve this, however, if its assets are large enough to fulfil the Foundation's mission permanently. At present this is not yet possible. Therefore it would be most desirable for the completion of asset development if more individuals would decide to consider donating to the Foundation and/or arrange to create a subfoundation. Such a good deed would also preserve your memory in honor over the long term. With a sufficiently large capital, the Foundation would in the future be in a position to support not only the Transylvania Institute but also other projects of our community. Foundations have a future.

Should anyone think about giving consideration to the Foundation in their last will and testament, one option would be to transfer the available portion of their savings to the Foundation in advance or to place it at the Foundation's disposal in the form of an interest-free loan. Such loans are also suitable for persons who are able to forego the interest income of their savings in favor of the foundation (help with a money-back guarantee). The loan is a safe investment. The Foundation is prohibited by law from touching its assets. Discretion is assured and the names of the contractual parties and sums involved are not published.

### Dauerhafte Sicherung angestrebt: Bericht der Stiftung Siebenbürgische Bibliothek

Die Jahresrechnung der Stiftung Siebenbürgische Bibliothek für 2017 offenbart zwei ganz unterschiedliche Aspekte. Einerseits ist der Buchwert des Stiftungskapitals um rund 72 000 Euro gewachsen, andererseits musste die Förderung des Siebenbürgen-Instituts mit Bibliothek und Archiv drastisch gekürzt werden.


Das Wachstum setzt sich aus direkten Zuwendungen von rund 65 000 Euro, rund 4000 Euro aus Erträgen der zinslosen Darlehen und rund 3000 Euro steuerfreier Dividenden zusammen. Die Hälfte der direkten Zuwendungen stammt von neun Personen bzw. Institutionen. Die andere Hälfte stammt von rund 250 Personen, von denen einige mehrere Male spendeten. Allen Darlehensgebern und Spendern dankt der Vorstand von ganzem Herzen für ihre Hilfe bei der Bewahrung der Zeugnisse unserer Kultur.

Um einer Abwärtsspirale bei den Erträgen und damit einer Entlassung von Personal zu entgehen (siehe dazu auch den Beitrag in Folge 19 vom 5. Dezember 2017, Seite 6), wurden 30 Prozent der Nettoerträge reinvestiert. Das allein wird jedoch nicht ausreichen, wenn demnächst die Zinsen nicht deutlich steigen. Anzeichen dafür gibt es leider keine.

Eine Reduzierung des Personals im Institut und in der Bibliothek wäre gleichbedeutend mit einer kompletten Schließung dieser für unser Selbstverständnis so wichtigen Einrichtung. Der ständige Zustrom von Büchern, Publikationen und Archivbeständen und die damit verbundenen Arbeiten, wie Durchsicht, Auslese, Katalogisierung, Digitalisierung, Datensicherung, Ausleihe, Heimversand, Korrespondenz, Buchhaltung, Projektdefinition und -überwachung, Beantragung von Mitteln, Instandhaltung der Gerätschaften, Verwaltung etc., werden nicht weniger, sondern mehr. Da helfen irgendwann auch Routine und freiwillige Mehrarbeit nicht mehr für eine verantwortungsvolle Arbeit. Hinzu kommt jetzt noch die Arbeit mit der Übersiedlung großer Bestände und der Arbeitsplätze in andere Räume des Schlosses.

Der Stiftungsvorstand appelliert deswegen an alle am Bestand der siebenbürgischen Identität interessierten Personen und bittet um ihre Hilfe. Drei Möglichkeiten sind aus unserer Sicht die aussichtsreichsten:

• Ausweitung des Personenkreises der Spender, weil auch viele kleine Spenden eine große Hilfe darstellen und alle Beteiligten das gute Gefühl spüren können, an einer wichtigen Aktion teilgenommen zu haben.



- Zur-Verfügung-Stellen von mehr zinslosen Darlehen, deren Erträge dem Stiftungsvermögen zufließen, den Darlehensgeber jedoch nicht direkt belasten. Die Namen der Darlehensgeber werden nicht bekannt gegeben. Das Darlehen kann jederzeit mit einer vereinbarten angemessenen Frist gekündigt werden. Die Sicherheit ist gewährleistet, weil das Vermögen der Stiftung nicht verbraucht werden darf.
- Schenkungen, Vermächtnisse oder Erbschaften. Diese führen die Stiftung am schnellsten zum angestrebten Ziel, den Bestand und die Funktion von Institut und Bibliothek auf Dauer absichern zu können. Schenkungen können über zehn Jahre von der Steuer abgesetzt werden. Auf Wunsch können diese Möglichkeiten anonym bleiben. Es können jedoch auch namensgebundene unselbstständige Unterstiftungen eingerichtet werden, die dem Namen des Erblassers/Schenkenden auf Dauer ein ehrendes Andenken bewahren.

Die Stiftung ist dabei, auch andere Quellen zu erschließen. So kann z. B. jeder, der bei Amazon über die Internetplattform "AmazonSmile" etwas bestellt und vorher "Stiftung Siebenbürgische Bibliothek" anklickt, ohne dabei Preisnachteile zu haben der Stiftung helfen, weil Amazon einen kleinen Prozentsatz der Einkaufsumme an die Stiftung überweist. Ähnliche Möglichkeiten werden untersucht.

It is that time of year that we remind our members that it is not too late to make their 2017 contribution into their ATS IRA. Deposits must be made by this year's tax filing deadline of April 17th. If you do not have an ATS Traditional or Roth IRA and have earned income, we recommend that you start one now! Both the Traditional and Roth IRA allow you to enjoy tax advantages while saving for your future. ATS has no administrative charges or service fees. All funds deposited are credited to your account to earn interest for you. (There are small surrender charges in the first five years.)

#### Traditional vs. Roth

With a Traditional IRA, you contribute pre-tax money, reducing your taxable income for the year, and thereby reducing your taxes, too. (Taxable income of \$60,000 and a \$5,000 contribution? Presto -- \$55,000 in taxable income for the year.) The money grows in your account and is taxed at your ordinary income tax rate when you withdraw it in retirement.

With a ROTH IRA, all withdrawals are tax free assuming you are over 59 1/2 years old and your IRA has been open for at least five years. Contributions must be made with earned money. There's no minimum age for opening a Roth, but whoever funds one, whether child or adult, must do so with earned income. For kids, allowance or birthday money doesn't qualify, but cash earned through babysitting or odd jobs can. For adults, qualified earnings include wages, commissions, and even alimony payments, but not inheritances, pension or disability income, or Social Security benefits.

Both Traditional and ROTH IRAS allow owners to begin taking penalty-free "qualified" distributions at age 59 1/2. However, ROTH IRAS require that the first contribution be at least five years before qualified distributions begins.

#### **IRA** contribution limits

The IRA contribution limits are the same for both the 2017 and 2018 tax years: \$5,500 -- plus an extra \$1,000 "catchup" contribution for those age 50 or older.

If you're thinking that it's February 2018 and it is too late to make a contribution to your IRA for 2017, you're in luck: The deadline for IRA contributions is actually the same as your tax-filing deadline, April 17. Thus, if you didn't make a contribution in 2017, you can make two in 2018, as long as you specify that one is for 2017 and you make it by April 17.
