PRESIDENT'S **MESSAGE**



Day. The idea of a special day to honor fathers and celebrate fatherhood was introduced in the United States. The nation's first Father's Day was celebrated on June 19, 1910, in the state of Washington. However, it was not until 1972, 58 years after President Woodrow Wilson made Mother's Day official, that the day honoring fathers became a nationwide holiday in the United States. For many of us, our fathers are our heroes. We appreciate them for their love and guidance. A good father can set an example of strength, honor, sacrifice, and responsibility. On Father's Day, make sure to you honor and thank your dad for his love.

Transylvanian Saxon Trivia: Another UNESCO World Heritage Site is Kelling Fortified Church. The structure was built in the 13th century by Count Chyl de Kelling. It is one of the most imposing defensive structures in Transylvania. First documented in 1269, the fortress served as the residence for Saxon nobility until 1430 when it was sold to the Saxon community. Enclosed by one and half rings of high walls fortified with a defensive tower to the south ad a gate tower to the north, the fortress withstood several Ottoman sieges. After the second wall was finished in the 16th century, a small Romanesque chapel was added as well as aa moat. The fivestory Siegfried Tower which is the landmark of this fortress, is endowed with defensive corridors and firing window. The Ottomans destroyed the village in 1658 but failed to destroy the citadel. Restoration work was done on the structure in the early 1960's. The tower hosts a museum detailing the Saxons' lifestyle and traditions while the chapel is used for lectures.





Another reason to buy LTC insurance, if you can afford it, is to leave an inheritance for children. LTC might preserve some assets.

Induction or Dissolution of Branches

ATS Branch 11, Lorain, merged with their Brother Lodge Branch 5, Lorain, as of December 31, 2016.

Board of Director's Reports

The Delegates were asked to hear all reports and act upon them collectively.

President's Report

President Miller-Malue gave the Presidents' Report. She extended appreciation to the members that have accepted leadership positions in their local branches as well as on the national level as well as to those who serve on Branch committees. Their time and efforts have helped to build a financially and culturally strong fraternal. She has visited over a third of the branches and looks forward to meeting with other Local Branches in the coming year.

President Miller-Malue expressed sadness by the deaths of Past ATS Trustee Andy Schiller, Chicago, Branch #9 in February 2017 and ATS 3rd Vice President John Boehm in January 2018.

President Miller-Malue reported the ATS assets have grown to over \$89 million. Our net gain was \$663,423 and our surplus increased to \$10,230,865. Our life and annuity premiums were up slightly from last year. Our Solvency Ratio has increased to 112.94% which reflects a strong and stable balance sheet. This ratio has shown an increase for the past ten years.

Unfortunately, our membership is declining. We need to work harder to get our family and friends to join our fraternal organization. Lastly, President Miller-Malue would like to thank everyone for the continued support and cooperation in maintaining a fraternal benefit society of which we can be proud to belong.

Secretary's Report

Secretary Gilles reported on the Membership and Insurance Activity for 2017. As of December 31, 2017, we issued 89 new annuity certificates with 63 new members. Despite the number of annuity deaths and surrenders, we still had a net increase of 3 annuity members. We issued 28 new life insurance certificates for 26 new members. However, also

due to life deaths and surrenders, we lost 140 members with life insurance policies. Our membership total, as of December 31, 2017, was 6,806, which is a decrease of 158 from the end of 2016. There were 2,447 annuity certificates and 5,707 life insurance certificates. The total life insurance value, as of December 31, 2017, was \$26,238,760, reflecting an increase of \$75,626, The total annuity value, as of December 31, 2017, was \$64,578,812, which is an increase of \$2,020,408.

Treasurer's Report

Treasurer Crawford reported on the financial condition of the ATS for the year ended December 31, 2017. Total assets of the ATS were \$89,313,861, which is an increase over the prior year of \$2,000,681. Included in the assets are approximately \$72 million in Bonds. Common stocks, other Invested Assets, and Short-Term investments total approximately \$13 million. Reserves totaled approximately \$72 million. Surplus at December 31, 2017 was \$10,230,865. Premium income totaled \$2,858,249 for the year, while Investment income was \$4,373,195. Benefits paid to members totaled \$4,091,957. Net income from Operations was \$663,423 for the year ended December 31, 2017. Treasurer Crawford reported that an Annual and Quarterly Financial Statements are filed with the State Insurance Departments and the NAIC. Also, a Management Discussion and Analysis Reports are filed quarterly with the Ohio Insurance Department. A new filing for 2018 is the Corporate Governance Annual Disclosure which must be filed by June 1st of each year.

Auditing Report

Brother Randall Floyd, Merrillville, Branch #26, Chairman of the Audit Committee, stated that the Trustees examined the ATS financial records at the Annual Audit. In their opinion, all controls and procedures were followed, and all records were accurate and in good order.

During 2017, James G. Zupka, CPA, Inc. conducted an independent audit for the fiscal year 2016 and in their opinion, our financial statements present fairly the financial position of the ATS. The Auditor's Report is filed with the State Insurance Departments and the NAIC. Annual and Quarterly Financial Statements are filed each year with the NAIC and the State Insurance Departments of Ohio, Pennsylvania, Indiana, Illinois, and Michigan.

A motion was made by Sister Jane Mowery, Lorain, Branch #5, seconded by Brother Daniel Schuffert, Merrillville, Branch #26 to accept the Board of Directors reports as given. Motion carried.

Report on the Committee on Rules

The Board of Directors, represented by Trustee Barbara Spack, presented the following Budget Proposals for each of the two-year periods (July 1, 2018-19 and July 1, 2019-20) for the Convention consideration and approval:

Salary Budget \$372,000 Sales Promotion \$60,000 Fraternal Activities \$55,000

Trustee Barbara Spack reminded the Delegates that they would vote on these proposals at a later time.

The proposed Constitution Changes were not read at this time since each Delegate had received a written copy of the proposed Constitution Changes. These proposed changes would be discussed and voted upon at a later time.

Reports by Standing and Special Committees

The Delegation was asked to hear all reports and act on them collectively.

Investment Committee

Treasurer Denise Crawford reported on the activities of the Investment Committee. During the year 2017, 6 issues of bonds were purchased in the amount of \$7,839,430. Five issues of bonds were sold, called, or matured with proceeds of \$2,030,064 and a net loss of \$250,931. The loss is the result of selling 2 different bonds that were decreasing in value. Also, in 2017, 4 stocks were sold with proceeds of \$407,577 for a capital gain of \$211,790. The selling of these stocks helped offset the loss of the bonds. The net investment yield to mean invested assets at December 31, 2017 was 5.08%.

The Investment Committee relies on the advice of our Investment Advisor, John Mc Pike of Investment Advisory Services. The Committee consists of President Joan Miller-

Malue, Robert Cunningham, Monica Gilles, Randall Floyd, and Denise Crawford.

Orphan Fund Committee

Chairman Robert B. Cunningham, III gave the Orphan Fund Committee Report. The Orphan Fund program provides monthly financial assistance in addition to the premium payments of the children's ATS insurance. During 2016, the program supported 10 children representing 5 families. Total cash benefits paid during 2016 totaled \$6,465. For 2017, the Orphan Fund supported 9 children from 5 families with total benefits of \$6,130. So far in 2018, the Program supports 6 children from 3 families. The decrease is due to children attaining the age of 19 and a parent remarrying. At Christmas, each child receives a monetary gift. The Orphan benefits are paid out of the ATS General Fund. Profits derived from the sale of history books and cookbooks are credited to the Orphan Fund and thereby assist in the financing of this program. In 2016 and 2017, The Saxon Orphan Fund received monetary donations from Henry Hum, Cleveland, Branch #33 and New Castle Branch #27.

The Orphan Fund Committee consists of the three Vice Presidents: Robert B. Cunningham, Monica Weber, and the late John Boehm, Jr.

Future Planning Committee

Chairman Jacob Spor gave the Future Planning Committee Report. Twenty-three Freshman academic scholarships and thirteen adult continuing scholarships were awarded this year for a total of \$33,400. The Academic Scholarship recipients are as follows:

Motion carried.

New Proposals

Second Vice President Monica Weber, co-chairperson of the Constitution Committee, brought up for discussion the proposed Constitution changes. The changes are as follows:

ARTICLE II – PURPOSE

Proposed addition:

(New) SECTION 2. The Alliance is a non-profit fraternal benefit society, organized without capital stock and carried on solely for the mutual benefit of its members and the beneficiaries having a lodge system, ritualistic form of work and representative form of government.

(Old SECTION 2 becomes SECTION 3)

Currently reads:

SECTION 2. The Alliance shall be organized and maintained without profit for the mutual benefit and protection of its members and their beneficiaries. It shall provide for payment of death benefits and may issue to its members term, life, endowment, and annuity certificates and combinations thereof, and other certificates which may, from time to time, inure to the well-being of its members, and

permitted under the Ohio Insurance Code.

Proposed change:

SECTION 3. The Alliance shall provide for payment of death benefits and may issue to its members' term, life, endowment, and annuity certificates and combinations thereof, and other certificates which may, from time to time, inure to the well-being of its members, and may provide for the payment of such other benefits as are permitted under the Ohio Insurance Code.

ARTICLE V - CONVENTIONS

Currently reads:

SECTION 5. The English or German language may be used in all meetings of the Alliance.

- a. Upon demand, important resolutions or motions shall be made in writing and given to the Secretary for reference and preservation.
- b. All official business, annual reports, etc., shall be written in the English language.

Proposed change:

When the nomination date has passed, the Board of Directors will provide the Alliance Branches with the list of nominees and their qualifications. Incumbent Officers of the Alliance are eligible for re-election and, if not present at the Convention, must send in writing a "consent to be nominated."

A nominee for election to Office must meet the following:

- a. Be of Transylvanian Saxon or German birth or a descendant thereof
- b. Be an American citizen
- c. Be a member of the Alliance in good standing for the past three years
- d. Possess general knowledge of the fraternal benefit system and the fraternal workings of the Alliance
- e. Have served as a Delegate to at least one previous National Convention
- f. Be willing to complete continuing education as designated by the Board of Directors of the Alliance
- g. Have the willingness and commitment to devote the necessary time to fulfill the duties of office
- h. Not be a current Officer in another fraternal benefit society

Proposed change:

A nominee for election to Office must meet the following:

- a. Be a member of the Alliance in good standing for the past three years
- b. Be an American citizen
- c. Not be an immediate family member of current officer or nominee. (Immediate family member shall be defined as a spouse, parent, child, sibling, grandparent, grandchild, stepparent or stepchild)
- d. Possess general knowledge of the fraternal benefit system and the fraternal workings of the Alliance
- e. Have served as a Delegate to at least one previous Convention
- f. Be willing to complete continuing education as designated by the Board of Directors of the Alliance
- g. Have the willingness and commitment to devote

the necessary time to fulfill the duties of office

h. Not be a current Officer in another fraternal benefit society

ARTICLE IX – DUTIES OF OFFICERS

- h. The Alliance Office Manager will be the Financial Officer authorized to purchase and sell securities as approved by the Alliance Board of Directors; to sign all checks, money order, to open new broker or bank accounts as approved by the President and Treasurer.

In the event of the death of all the named beneficiaries before the decease of such member and the member has made no disposition thereof, the benefits shall be paid to the estate of the insured provided that claim thereon is made within four years after death.
- b. A benefit Certificate shall in no case be assigned for the purpose of changing the beneficiary named therein or for any other purpose and neither shall the beneficiary named therein be changed by will or testament of the member.

In the event that all beneficiaries are deceased and there is no estate, State regulations will be applied for disposition of the claim.

1st Vice President Robert Cunningham gave a report on the Saxon Relief Fund. This fund was created in 1982. The money is forwarded to the Landsmannschafts of Austria and Germany, who then distributes it to Saxon causes in Romania. In 2017, we received donations totaling \$2,945.00. So far in 2018, an additional \$1350.00 has been received. In 2017 we forwarded \$1,900.00 to the Sozialwerk der Siebenbürger Sachsen on Germany.

Brother Cunningham reported on Schloss-Horneck, the Saxon museum in Gundlesheim, Germany. In 2015, the Verband der Siebenbürger Sachsens in Deutschland had purchased the property for one million Euros to make a world central location for a Saxon library, artifacts, historical documents and meeting place. The Federation of Transylvanian Saxons had asked for all Saxon organizations to help with the funding of this historical facility. As of May 2018, donations have been transferred totaling \$18,000.00. The one million Euro note has been paid in full. Continued donations will be needed for upkeep of this facility.

Another way to save for retirement is with an ATS Traditional or Roth IRA. Both types of IRAs provide a good choice for retirement savings. Roth IRA and Traditional IRA differ significantly in the way they are taxed. A Traditional IRA is tax-deferred until withdrawal but grows tax free until retirement. A Roth IRA is a retirement plan which allows contributions to be taxed up front and then withdrawals are made tax free as long as the person has had the Roth IRA for over five years and is at least 59 1/2 years old. Contributions to a Traditional IRA can be deductible but contributions to a Roth IRA are non-deductible. A Roth IRA, unlike a Traditional IRA has no 70 1/2 age rule. A person can make contributions to a Roth at any age as long as a person has taxable compensation. Contributions into a Traditional IRA can only be made before the age of 70 1/2. The Traditional IRA requirement that a minimum withdrawal must be made starting at age 70 1/2 does not apply to a Roth IRA.

The Traditional IRA may be better for those who expect their tax rate to be lower when withdrawals are taken while those who choose a Roth IRA might expect their tax rates during retirement to remain the same or higher as their current tax rate.
