At the Bund's first national convention held on August 31, 1902 the name of the new organization was changed to the Central Verband der Siebenbuerger Sachsen. At the convention in 1965, the name was changed to the English translation, the Alliance of Transylvanian Saxons. Branch 1 was founded in 1895 and Branch 4 was the first ladies Saxon society that was founded on March 3, 1902. Our membership at Cleveland Branches 1 and 4 have worked hard to maintain our Sachsenheim where we have been able to promote our Saxon culture. We are proud that today we still have a singing society, the Eintracht-Saxonia Sachsenchor and the Cleveland Saxon Dance Group. ever in hosting it and I hope everyone will help them make this a successful weekend.

Did you know that there are scientific results of studies for how many licks it takes to get to the Tootsie Roll center of a Tootsie Pop? We all remember the classic 1970 TV commercial with a boy asking how many licks it takes. The wise owl starts counting, gets to three, and then bites into the lollipop to get to the Tootsie Roll inside. According to the Tootsie Roll website, various scientific studies have attempted to determine the answer. Purdue University engineering students used a licking machine, modeled after a human tongue, to report an average of 364 licks. Twenty of this group's volunteers assumed the challenge without the help of machinery and averaged 252 licks. A doctorate student from the University of Michigan reported his licking machine required 411 licks. Bellarmine University in Louisville completed a very detailed, controlled study using gender and flavors (grape, orange and raspberry). The 130 participants had results from 104 to 241, with an average of 175 licks. Orange was the flavor consumed the quickest. Another study, undertaken by junior high students at Swarthmore School, reported an average of 144 licks. As all of these studies resulted in such different numbers, the world may indeed never know just how many licks it really takes to get to the Tootsie Roll center of a Tootsie Pop!

## Seven ways to hammer hay fever

If you are among the one-in-four people who are sensitive to pollens or mold spores, remember these ways to fight mother nature

- 1. Stay inside most of the time between 9 a.m. and sunset. Doctors at the National Jewish Medical and Research Center in Denver say that during the day, thermal currents and winds toss ragweed pollen and mold spores around in the air.
- 2. Protect your eyes from flying pollen. Wear glasses, sunglasses or wraparound goggle sunglasses.
- 3. Go out after a downpour. Heavy rains wash pollen away. Stay inside after a light rain, which could make the pollen situation worse.
- 4. Check your local air quality. Pollution makes allergies worse. If there is a pollution alert, stay inside as much as possible.
- 5. Use your air conditioner. It recirculates air instead of bringing pollen-laden air inside. Change the filter frequently. Use the air conditioner in your car as well.
- 6. Use a dehumidifier in damp areas to fight mold. Wash the shower curtain and bath rugs frequently.
- 7. Talk to your doctor. If your medication is barely keeping up with the high pollen count, ask if you can increase it.

Work with your doctor to determine which medication is best for you. Often, people have to try two or three before finding the one that works best for them.

The editors of Prevention magazine say hypnosis may decrease the effects of allergies. The allergies are not psychosomatic, but studies show that the mind controls more of your physical responses than many doctors or patients realize.

#### State fairs are new each year, but they were born in a millennium past

Our modern state fairs feature agricultural displays and competitions, races and entertainments of many kinds. They are an annual event attended by hundreds of thousands of people. But when did all of this begin?

How about 14,000 years ago -- or even before that? In China, the Rites of Chow-li, a fair-like event, dates from the 12th century B.C. In Mexico, the Aztecs had festivals and

fairs a few centuries later. In Greece, the Olympic Games were primarily athletic, but trade was conducted at the same time for grain, linens, carpets and furniture.

The word "fair" is believed to originate from the Latin word, feriae, meaning festival or holiday. From the fifth century of the Christian era, fairs were held in Champagne in France. Early medieval festivals were held in the seventh century



in Rome, Antwerp, Frankfurt, Leipzig, Madrid and the British Isles, according to Collier's Encyclopedia.

Trade conducted at early fairs resulted in benefits that have survived from antiquity. The modern system of Troy weights, for example, is derived from the system employed at the medieval fair in Troyes. Some historians say paper money originated as promissory notes between merchants at these fairs.

Medieval fairs were governed by laws enforced by their own officials and courts. The laws maintained peace and order, enforced quality standards for trade goods and prevented fraud. The guarantee of freedom of attendance and honest trading at French fairs led to a pledge all merchants had to make "to keep the peace and to deal honestly."

The first fair in the U.S. took place in New Haven Conn.,

in 1644, and was devoted to the exhibition of livestock and agricultural products. Other early fairs were held in New Hampshire, New Jersey, Maryland and South Carolina.

Two of the oldest state fairs started in 1841 in New Brunswick, N.J. and Syracuse, N.Y. Others states soon held their own state fairs.

The fair you attend now was born at the dawn of recorded history.

In every city and every burg, there is someplace

you can sing along to your favorite tunes -or watch someone else do it. There are good
singers, and bad singers, familiar tunes and
some you forgot or never knew. Regulars
fans get to know the singers and each other.
It is like a weekly social event.

If you haven't been to karaoke, you can search online for events in your area. Smaller venues, usually bars, have a more intimate audience. Bigger venues tend to attract better singers, but can be more impersonal. Show up early to get the best seats. When the show starts, applaud every singer and give newbies encouragement.


If you want to try out your vocals, practice



at home first. Rehearse a high energy song and a slower song. The later it gets, the less likely that a long, slow ballad will be appreciated. You can listen and practice your songs on sites such as Sunfly or Ameritz.

When you get to the venue, you will give your name and song to the karaoke DJ. These days, most every song is available, but in some cases the choice can be limited to songs listed in a book.

When you are called to the front, sing with confidence, and when finished go immediately to your seat. Making a speech to the audience or lingering up front is frowned upon.

#### Low-fat or full-fat dairy? It's complicated

Stick to low-fat or fat-free dairy, nutrition guidelines frequently advise, and receive all the nutritional benefits of dairy (like calcium and protein) without the saturated fat that can raise cholesterol and lead to heart attacks and strokes.

That was the advice for decades from venerable sources like the American Heart Association, the American College of Cardiology and even the United States Department of Agriculture. But newer research suggests that fat in dairy isn't necessarily bad -- and could offer some useful benefits.

In a 2020 literature review published in the journal Advances in Nutrition, researchers concluded that instead of increasing risk factors for cardiometabolic health conditions like heart diseases or type 2 diabetes,

full-fat dairy was associated with neutral or improved outcomes. Another study, published in 2021 in the American Journal of Clinical Nutrition, found that among 73 patients with metabolic syndrome, eating at least three servings of fullfat dairy each day had no effect on their blood pressure or cholesterol compared to other patients who avoided dairy or consumed reduced or fat-free versions.

Researchers are still trying to figure out how full-fat dairy works and who is most likely to benefit. According to the British Heart Foundation, the nutrients found in milk may work in combination to confer health benefits. The higher fat content may also increase satiety, which can lead to eating less overall, according to National Public Radio.

#### Extra watermelon? Try these refreshing drinks



Is there anything more delicious than late summer watermelon, ripened in the hot sun until juicy and fragrant? Not really, and when you find yourself wilting in the late summer heat, a cold watermelon agua fresca or icy watermelon slushie are perfect to help you cool down and relax. Adults and kids alike will love them, and it's easy to add your own spin with extra flavorings or cantaloupe instead of watermelon.

## Watermelon agua fresca

Ingredients:

4 cups cubed seeded watermelon 1/2 cup water 1/2 cup white sugar (or to taste)

1 lime 24 fresh mint leaves ice

Combine watermelon and water in a blender and puree until smooth. Add sugar to taste. Slice lime into small wedges (you'll need about 8), then place one wedge into each serving glass, along with 3 mint leaves. Crush with a cocktail muddler (a wooden spoon handle also works), then add ice. Pour the agua fresca over the ice, stir, then serve.

#### Watermelon slushie

4 cups cubed seeded ripe watermelon (188 calories) 2 tablespoons sugar (32 calories) 1 tablespoon lime juice (30 calories) About 3 cups ice

Blend the fruit, melon, sugar and juice until liquid. Add ice and continue to blend until the liquid reaches a slushie consistency.

In the whole blend there are about 250 calories.

Yard sales, garage sales, tag sales -- by any name -they are an American tradition and, as it happens, the biggest monster of a yard sale begins along US Route 127, where the stuff from one garage gets put into someone else's garage.

The 127 Yard Sales is an annual tradition beginning on the first Thursday through Sunday in August, according to Interesting

It is so big that it covers 690 miles, running through lawns, garages, churches, and public lots through Alabama, Georgia, Tennessee, Kentucky, Ohio, and Michigan, all along US Route 127. It starts up in Addison, Michigan and ends in Gadsen, Alabama.

The first event took place in 1987 when a Tennessee official was looking for a



way to generate traffic away from the interstate to more rural communities.

Like all yard sales, the 127 is a feast for treasure hunters. You can get anything and everything along the route, and yard sales are famous for creating the occasional millionaire.

The name of this Society shall be SAXON CLUB, YOUNGSTOWN, OHIO and BRANCH 30 of The Alliance of Transylvanian Saxons.

#### ARTICLE II PURPOSE

Section 2.

A member of this Society may retain their membership in the Society even though they relocate in a city in which there may or may not be another Society. Our Society will accept members who wish to join by transferring from another Society. A Certificate of Transfer form must be filed with

Section 3.

Members are to keep the Financial Secretary informed of any changes of contact information.

Section 4.

Upon written request all Affiliated Organizations are required to provide detailed financial reports within 30 (thirty) days. Upon failure to furnish said annual report, said affiliated organization shall be denied its status as an affiliate of Branch 30.

Section 5.

All standing committees or other committees of the Society, not having previously submitted a written report, shall submit a report of its committee at the March General Meeting together with a written Financial Report.

#### ARTICLE IX. CHARGES, GRIEVANCES, & RECALL

Section 1.

Procedures shall be the same as that set forth by the Constitution of the A.T.S., except that the Grievance Committee, when needed, shall be made up of five (5), non-office holding members in good standing; selected at random from the most recent general meeting attendance.

Section 2. Unless otherwise provided in the Branch Constitution, when a dispute, charge, or

grievance arises internally among members of the Branch; they shall specify same in writing to the President. The President will in turn forward it to the Grievance Committee. The committee shall act upon the charges made. Report their findings and recommendations to the Body at the next regularly scheduled Branch Meeting.

Section 3.

The President shall immediately notify the office of the A.T.S of any external dispute, charge, or grievance between Branch 30 and any Branch or member thereof. The President shall in turn receive detailed written copy of the Procedure necessary to resolve the issue in an impartial fraternal manner.

Section 4

The following procedures are mandatory and must be followed prior to any legal action in a public court of law or equity.

Section 5.

A resignation may be requested by the President of any officer who fails to perform their duties as prescribed in the Constitution. The President may be recalled by a 2/3 majority of the body after eleven (11) members have submitted a valid reason mailed to the Recording Secretary and reviewed by the Board of Grievances.

Section 6

Any member who, at a meeting or outside of the Society, is guilty of improper action towards another member (so far as the Society affairs are concerned), or who shows themselves underserving of Society membership, shall be suspended or expelled.

#### ARTICLE X. AMENDMENTS

All articles and Sections of the Constitution may be changed or amended. All proposed changes and amendments shall be submitted in writing to the Recording Secretary. Changes shall be signed by five (5) members in good standing, read by the Recording Secretary at a regular meeting and then submitted by the Recording Secretary to be published in at least two (2) consecutive publications of the official journal of the ATS prior to the General Meeting. Approval shall be at a meeting designated.

ARTICLE XI. MERGER AND/OR DISSOLUTION OF THE SOCI-

Section 1 As long as eleven (11) members in good standing desire the continuation of the Society, it cannot be disbanded.

Section 2

Should the society be disbanded, all remaining assets shall be remitted to the national alliance where they will be held in trust for one (1) year. If, during that year, the Society is re-activated the assets will be returned to the Society.

Section 3.

The Society may consolidate or merge with an branch of the A.T.S.

#### ARTICLE XII. ORDER OF BUSINESS

Opening of the meeting.

#### **BY-LAWS**

Section 1. These By-laws pertain to all fraternal and social members, visitors, and guests of Youngstown Saxon Club.

Section 4. The term "guest" as used in these rules means a person who is NOT a member. A member introducing a guest to the club shall enter their Name, Member Number, and the Guest'(s) Name in the Guest Register, together with the Date.

Section 5. Guests, when accompanied by a member in good standing, may be admitted to the lounge, main dining room, and the lower lounge, unless otherwise stated. Such member shall be responsible for the conduct of their guest(s).

Section 6. All entertainment is subject to the approval of the Board of Directors.

Section 7. The Club Lounge facilities shall be open in accordance with Ohio Law and on special occasions regulated by the Board of Directors.

Section 8. The Club facilities may be rented for meetings, parties, bereavements, and/or various other functions; only on approval of the Board of Directors and/or the Business Manager.

Section 9. No Club Property shall be removed from the premises for personal use.

Section 10. Conduct of members and guests:

Every person shall conduct themselves in an orderly manner. Any unbecoming behavior (including on social media platforms) which might discredit the Club shall be promptly reported to a member of the Board of Directors and/or the Business Manager.

For the following offenses, the penalty clause set forth hereafter will apply:

- a. OFFENSES
- 1. Profanity (loud and boisterous) or obscene language,
- 2. No smoking or vaping in Main Building or Pavilion.
- 3. Littering or spitting on floors.
- 4. Improper use of lavatory facilities.
- 5. Removal of Club Property for personal use.
- 6. Misuse and/or destruction of Club Property.
- 7. Possession of illegal drugs or firearms.
- 8. Any unbecoming behavior, including on social media platforms, which might discredit the club.

b. PENALTY CLAUSES Any member or the Business manager may prefer charges for a violation of this section to the Board of Directors, who shall forthwith notify the offending member that their club privileges are temporarily suspensed until a formal hearing by the Grievance Committee can be held. This hearing shall be conducted within ten (10) days of the notification. If hearing cannot be held within the 10 days, member's privileges shall be reinstated until such time a formal hearing can be held. Upon such formal hearing—if found guilty, the Penalty Clause herein set forth shall apply without

-For violation of No. 1, there will be a seven days suspension of club privileges for a first offense, thirty days for a second offense, and ninety days for a third offense.

-For violation of Nos. 2 and 3, there will be thirty days suspension of privileges for a first offense, sixty days for a second offense and one hundred and twenty days for a third offense.

-For violation of No. 4, there will be sixty days suspension of club privileges for a first offense, ninety days for a second offense, and one hundred and eighty days for a third offense.

-For violation of No. 5 there will be a one-year suspension of club privileges for a first offense and termination of membership for a second suspension.

-For violation of Nos. 6 and 7 there will be a termination of mem-

-For violation of No. 8 will be determined by the grievance com-


- No member or guest shall bring food or intoxicating beverages on the club premises unless during rental of the Pavilion, Ballroom or
- The Board of Directors and/or the Business Manager shall have charge of the Club Rooms and all Club Property, and it shall be their duty to enforce the rules of the Club as set forth in the Constitution and the By-Laws.
- Should a Fraternal Member, for any reason, give possession of their personal Club identification as supplied by the Club, such Fraternal Member shall have their club privileges suspended for six months. Subsequent infractions will be brought before the Board of Directors.
- Lounge doors will be locked at all times; the exception being a public function or rental of the Lower Lounge.

- Fraternal Members shall receive a discount on rentals. Social members shall receive a discount equal to half that of Fraternal Members. To receive the discount, the membership must exist one year prior to the event. If claiming Fraternal or Social membership discount, said member must sign contract(s) and said member shall be held responsible for facilities.
- All sub-organizations of the Youngstown Saxon Club and the Youngstown Saxon Culture Group shall be allowed to use the Club facilities at no cost.
- All members of sub-organizations must be members of the Youngstown Saxon Club, or any Saxon Club affiliated with the
- As long as the Society is affiliated with the Alliance of Transylvanian Saxons, all Fraternal Members of this Society shall comply with the Constitution of the ATS. Refusal to do so shall result in expulsion from this Society.

#### Section 11. DUTIES OF STANDING COMMITTEES

The Audit Committee shall consist of five (5) members who shall audit the Society's books annually and report to the meeting. Three (3) to be present to audit the books.

Am Nordufer des Eriesees, im Südwesten der kanadischen Provinz Ontario, liegt Elgin County mit seinem Verwaltungssitz, der Stadt St. Thomas. Zum County gehört Aylmer, das den Lesern dieser Zeitung durch die Nachrichten unserer Landsleute aus Kanada bekannt sein dürfte. In Aylmer leben viele ausgewanderte Siebenbürger Sachsen, und dort steht auch seit über 50 Jahren die Saxonia Hall, Veranstaltungsort und Treffpunkt für die ansässigen Kanadier mit deutschen Wurzeln.

Kanada ist ein traditionelles und beliebtes Einwandererland. Die St. Thomas-Elgin Local Immigration Partnership, ein gemeinnütziger Verein vor Ort, hat sich kulturelle Vielfalt auf die Fahnen geschrieben und steht Neuankömmlingen aus anderen Ländern bei der Eingliederung mit Rat und Tat zur Seite. #### Youngstown Saxon Club, Branch 30 \*House Rules\*

The following rules and regulations shall govern the operation of the Club rooms of the Youngstown Saxon Club, Branch 30.

All members of the Youngstown Saxon Club and Auxiliaries in good standing are members of the Club.

VISITING SAXONS shall be entitled to all the privileges of the Club after entering their name, residence, Home Club/Branch number in the Visitor's Register, and obtaining a pass from the Board of Directors and/or a bartender.

Guests, including minor children, when accompanied by members in good standing may be admitted to the lounge, main dining room and the lower lounge, unless otherwise stated.

The term "VISITOR" as used in these rules means a non-member. A member introducing a VISITOR to the Club shall enter the date, VISITOR'S Name and Member's Name and Member Number in the VISITOR'S Register.

Any member may introduce Visitors to all privileges of the Club; however, such privileges may be subject to the approval of the Board of Directors. Such member shall be responsible for the conduct of their guest.

All entertainment is subject to approval of the Board of Directors.

The Club facilities may be open from 12:00 p.m. until 1:00 a.m., except on Sundays and on special occasions to be regulated by the Board of Directors and as alcohol license requires.

The Club facilities may be rented for meetings, parties, bereavements, and various other functions only upon approval of the Board of Directors and/or the Business Manager.

Conduct of Members and Guests:

Every person shall conduct themselves in a proper manner. Any unbecoming behavior (including on social media platforms), which might discredit the Club shall be promptly reported to a member of the Board of Directors and/or the Business Manager

For following offenses, the penalty clause set forth hereafter will apply:

#### Offenses:

- 1. Profanity (loud and boisterous) or obscene language including on attire.
- 2. No smoking/vaping in Main Building or Pavilion.
- 3. Littering or spitting on floors.
- 4. Improper use of lavatory facilities.
- 5. Removal of Club Property for personal use.
- 6. Misuse and/or destruction of Club Property. 7. Possession of illegal drugs and/or firearms.
- 8. Any unbecoming behavior (including on social media platforms) which might discredit the club.

#### **Penalty Clauses:**

-For violation of No. 1, there will be a seven day suspension of club privileges for a first offense, thirty days for a second offense, and ninety days for a third offense.

-For violation of Nos. 2 and 3, there will be thirty days suspension of privileges for a first offense, sixty days for a second offense and one hundred and twenty days for a third offense.

-For violation of No. 4, there will be sixty days suspension

of club privileges for a first offense, ninety days for a second offense, and one hundred and eighty days for a third offense.

-For violation of No. 5, there will be a one-year suspension of club privileges for a first offense and termination of membership for a second violation.

-For violation of Nos. 6 and 7, there will be a termination of membership.

-For violation of No. 8, will be determined by the grievance

Any member or the business manager may prefer charges for a violation of this section to the Board of Directors who shall forthwith notify the offending member that his Club privileges are temporarily withdrawn until a formal hearing by the Grievance Committee can be held. This hearing shall be conducted within ten (10) days of the notification. If hearing cannot be held within the ten (10) days, the member's privileges shall be reinstated until such time a formal hearing can be held. Upon such hearing, if found guilty, the Penalty Clause herein set forth shall apply without exception.

IX

No member or guest shall bring food or intoxicating beverages on Club premises (excluding rental of facilities).

A violation of this section will result in a six-month suspension for the offending member or the member whose guest so offends, said suspension to become effective in the same manner as set forth in the last paragraph of Section VIII.

The Board of Directors and/or the business manager shall have charge of the Club Rooms and all the Club Property. It shall be its duty to enforce the rules of the Club as herein set forth or as contained in the Constitution and/or Bv-Laws.

Should a social member, for any reason, give possession of their personal club identification as supplied to them by this club, such social member shall have their membership immediately revoked. They may reapply for social membership after a one-year suspen-



#### Enjoy (sort of) the Orb Weaver in August

Here you are enjoying your late summer walk through the woods when, eww, you walk right into a spider web.

The web is everywhere! Is the spider on you? Yuck!

It's not your imagination that spider webs are everywhere in August into September and even October if the weather is warm. That's the time when many spiders weave their webs, especially the large Orb Weaver, a spider of extraordinary art and grace.

Their complicated, many layer webs are a work to behold. The spiders themselves are not dangerous and they won't bite you. The spiders can be pretty brave. It's a game for country children, to find and Orb Weaver on the web and tap his yellow back, making him bounce on the web.

The webs can be enormous, more than three feet in diameter sometimes, yet weirdly invisible. To best admire the web, take a hike after a rain and you'll see the droplets glistening on the complicated web. The rain brings out vegetation and insects and the Orb Weavers will be out in force spinning to net their prey.

Orb Weavers are part of the Araneidae family, a large group of spiders with many colors and shapes. The daytime Orbs are brightly colored with orange or yellow patterns on black. The spiders you see weaving their webs in the fall are females.

The spokes of the web are roads for the spider to crawl on, but the loops of the web are covered in a sticky substance that is perfect for catch insects. It can also catch small birds. Gardeners have seen birds the size of sparrow caught haplessly in the Orb Weavers web.
