Who inherits the proceeds of your 401(k)?

Regardless of what it says in your will or any beneficiary designation form, your current spouse is automatically entitled to all of the proceeds in the account. If you want to leave the account to someone else, your spouse must file a written statement waiving rights to it.

That applies to 401(k) accounts you have from previous employers as well. In most cases, the spouse becomes the beneficiary the moment you say "I do." Any prenup does not count. The spouse still gets the money.

Who inherits your IRA accounts?

In most states, your will does not affect who inherits any of your IRAs at the time of your death. The person who gets the cash will be the one named on the beneficiary form. It doesn't matter how long ago you named the recipient. A spouse you divorced 30 years ago will get the money if you haven't changed the beneficiary.

Caution: Once you are married, you can't transfer the assets of a 401(k) to an IRA, but it can be done before you marry.

Who gets your life insurance?

Whoever is named as beneficiary gets the proceeds of life insurance, regardless of any will or remarriage. It's important to check your beneficiary every few years.

Savings Bonds go paperless

If you want to buy a U.S. Savings Bond after December 31, 2011, you will have to do it over the Internet. After that, savings bonds have to be bought through Treasury Direct, their Web-based program. But these bonds can never be lost. Right now, over \$16 billion in unredeemed bonds no longer earn interest.


By the Numbers: Macy's Thanksgiving Day Parade

- The Macy's Thanksgiving Day Parade spans 43 blocks covering 2-1/2 miles.
- There are usually 12 giant character balloons and over 30 novelty balloons in each parade. These balloons use over 400,000 cubic feet of helium to stay aloft.
- All the floats in the parade must be able to collapse to no more than 12-1/2 feet tall and 8 feet wide, enabling them to journey from the Macy's Parade Studio in Hobo-

- ken, New Jersey, through the Lincoln Tunnel and into New York City the day before the parade.
- In total, there are over 10,000 participants in the parade each year. Over 800 of those are clowns.
- About 3 million people attend the parade each year, with another 50 million watching the parade on television.

Ankle sprain's not serious? Maybe it is



If you've sprained your ankle and are writhing in pain, it's time to go to the emergency room. You could have a broken bone or torn ligaments, making the sprain far more than common. A complete tear of one or more ligaments can cause damage to the ankle itself.

With luck, the doctor, after x-rays, will classify your sprain as Grade 1.

That means the **RICE** will work.

Rest the ankle, no walking,

Ice it for 20 minutes at a time,

Compression, use an ace bandage to immobilize it, but not too tightly,

Elevate the ankle for 48 hours.

For a Grade 2 sprain, which is worse than a Grade 1, RICE will work, but the sprain will require more time for healing. The doctor may use a device to immobilize and splint the ankle.

A Grade 3 sprain can cause permanent instability if not properly treated. Surgery is rarely needed, but a short leg cast or cast-brace may be used for two to three weeks.

The Grade 3 sprain calls for rehabilitation to decrease pain and swelling and to prevent chronic problems. Ultrasound and electrical stimulation may be used.

At first, rehabilitation exercise may involve range of motion or controlled movement of the ankle joint without resistance.

Lower extremity exercise and endurance activities are added as tolerated. Proprioception training is very important. Proprioception is defined as the ability to establish a sense of position in space, especially at a joint.

Without proper treatment, the ankle may become permanently unstable, resulting in many ankle sprains in the future.


One of the most touching Norman Rockwell paintings graced the cover of Novem-



Get your tax break on assisted living expenses

Some or all of the costs may be tax deductible. They include one-time entrance fees and monthly fees under the 1996 Health Insurance Portability and Accountability Act (HIPAA). They should be reported on Schedule A. If a resident doesn't require medical care, a percentage of the costs will count.

The taxpayer must itemize deductions, and expenses must exceed 7.5 percent of the taxpayer's gross income.

An adult child can deduct the medical expenses of his or her parent if providing 50 percent of more of the parent's support costs.

3. Your turkey should not be stuffed until right before entering the oven, and your oven temperature should be set to no lower than 325 degrees.

4. Promptly refrigerate all leftovers in tightly covered containers. If food has been left out longer than two hours, it should be discarded. Refrigerated stuffing should be eaten within two days; refrigerated turkey should be consumed within three to four days.

Heimatortsgemeinschaften erörtern Rettung des Kulturerbes und Beitritt zum Verband der Siebenbürger Sachsen

Die 16. Tagung des Verbandes der Siebenbürgisch-Sächsischen Heimatortsgemeinschaften e.V. fand mit zahlreicher Beteiligung der Heimatortsgemeinschaften (HOG) vom 14. bis 16. Oktober im Heiligenhof in Bad Kissingen statt. Die wichtigste Entscheidung war der Beschluss, dass der HOG-Verband Beitrittsverhandlungen mit dem Verband der Siebenbürger Sachsen in Deutschland aufnehmen wird. Überraschenderweise kündigte der HOG-Verbandsvorsitzende Michael Konnerth an, aus gesundheitlichen Gründen sein Amt ruhen zu lassen.

Ein Großteil der Tagung war dem kulturellen Erbe der Siebenbürger Sachsen gewidmet. Horst Göbbel referierte am ersten Abend zum Thema „Hat unser Kulturerbe in Siebenbürgen noch eine Zukunft?“. Der Vortrag führte den Tagungsteilnehmern eindrucksvoll die heutige Situation des in Siebenbürgen verbliebenen Kulturerbes der Siebenbürger Sachsen vor Augen, wobei als Kulturgut nicht nur die architektonischen Denkmäler wie Stadtkirchen und Kirchenburgen gelten, sondern auch wertvolles Kircheninventar, Bestände in Bibliotheken, Archiven und Museen, oder auch die Volkskunst. Göbbel vertrat die These, dass in Siebenbürgen zwar nicht alles gerettet werden könne, jedoch wesentlich mehr, als auf den ersten Blick möglich erscheint. Die wenigen in Siebenbürgen lebenden Landsleute und die Evangelische Landeskirche seien von der Größe der Aufgaben überfordert. Die außerhalb Siebenbürgens lebenden Landsleute bräuchten vor Ort in Siebenbürgen gleichgesinnte Partner. Viele Siebenbürger Sachsen müssten ihr Verhältnis zu „den Rumänen“ überdenken und sie langfristig als Erben unserer Hinterlassenschaft in Siebenbürgen betrachten.

Als zukunftsweisendes Beispiel, wie Kulturgut gerettet werden kann, stellte Horst Göbbel die Lage in Nordsiebenbürgen vor. Nachdem sich hier die meisten Gemeinden mit der Flucht 1944 oder in den Jahren danach aufgelöst hatten, sei hier schon vor einigen Jahrzehnten die Frage der Rettung der evangelischen Kirchen gestellt worden. 23 evangelische Kirchen seien an andere Konfessionen, hauptsächlich orthodoxe Gemeinden, übergeben worden. Diese Gotteshäuser befänden sich heute größtenteils in einem sehr guten Zustand, wohingegen Kirchen ohne neuen Nutzer heute als Ruinen daständen oder, wie in zwei Fällen, wegen Baufälligkeit abgetragen worden seien.

Die eigentliche Tagung, zugleich auch Mitgliederversammlung des HOG-Verbandes, wurde am Samstagmorgen von Michael Konnerth eröffnet. Als Gäste konnte Konnerth den Bischof der Evangelischen Landeskirche A.B. in Rumänien, Reinhart Guib, den Hauptanwalt der Landeskirche, Friedrich Gunesch, den Stellvertretenden Bundesvorsitzenden des Verbandes der Siebenbürger Sachsen, Rainer Lehni, sowie den Stellvertretenden Vorsitzenden der Stiftung Siebenbürgische Bibliothek, Wilhelm Hietsch, herzlich begrüßen.

Bischof Reinhart Guib, erstmals bei der HOG-Tagung dabei, sprach über die aktuelle Lage der Landeskirche in Siebenbürgen. In der Heimatkirche habe nach seiner Wahl zum Bischof Ende 2010 ein Weiterentwicklungsprozess eingesetzt, um die Ziele der Kirche für die nächsten ein bis zwei Jahrzehnte festzulegen. Mit rund 13000 Seelen und 40 Pfarrern sei die Landeskirche heute eine kleine Kirche, jedoch mit einer großen Wirkung nach außen. Bischof Guib stellte aber auch fest, dass der Landeskirche Kapazitätsgrenzen gesetzt seien. Was früher 300000 Gemeindeglieder gemacht hätten, machten heute die genannten 13000. Das Kulturerbe sei Chance und Belastung zugleich. Der Bischof wies auch darauf hin, dass nicht alles Kulturgut gerettet werden könne.

Mehrere Arbeitsgruppen beschäftigen sich mit der Zukunftsfähigkeit der Kirche im nächsten Jahrzehnt. Neben geistlichen und theologischen Fragen würden dabei auch Aspekte wie kirchliche Organisation, Kommunikation und Öffentlichkeit, kirchliches Kulturerbe sowie Verwaltungsfragen erörtert. Die Kirche solle zu ihren Wurzeln stehen, gleichzeitig aber auch Neues zulassen. Der Informationsfluss über alle Gemeindeebenen müsse gewährleistet werden, die Webpräsenz der Landeskirche werde derzeit umfassend

erneuert. Der Bischof betonte die notwendige Zusammenarbeit mit den ausgewanderten Landsleuten, deren Präsenz in Siebenbürgen wichtig sei. Die größte Herausforderung für die Landeskirche sei das kulturelle Erbe in Siebenbürgen. Von rund 1300 Anträgen auf Rückgabe enteigneter Gemeinschaftsimmobilien seien bislang erst 500 behandelt und meistens positiv beschieden worden. Bei Arbeiten an den Kirchenburgen sei auch die Hilfe der Heimatortsgemeinschaften gefragt. Bischof Guib wies auch auf die Nutzungskonzepte der einzelnen Kirchenburgen hin, um diese nachhaltig zu sichern, wobei nicht nur eine streng kirchliche Nutzung denkbar sei. Zum Bereich des Kulturgutes führte Bischof Guib auch Projekte an wie die Sicherung der Archive und Kircheninventare, die Einrichtung eines Zentraldepots und die Aufstockung des Zentralarchivs. Bischof Reinhart Guib dankte den Heimatortsgemeinschaften für ihren Einsatz in den Heimatgemeinden, ohne deren Engagement vieles nicht möglich wäre: „Wir sind auf Euch angewiesen“.

Über die aktuellen Projekte im Bereich Renovierungsarbeiten an Kirchenburgen informierte anschließend der Hauptanwalt der Landeskirche, Friedrich Gunesch. Das größte derzeit laufende Vorhaben sei das Projekt „18 Kirchenburgen“, das mit 4,5 Millionen Euro aus EU-Mitteln bezuschusst werde. An neun Kirchenburgen werde gegenwärtig gearbeitet (geplantes Ende ist Herbst 2013). Fortgeführt werde auch das Dächerprogramm für Kirchen und Befestigungsanlagen. Zu den Vorträgen von Bischof Guib und Hauptanwalt Gunesch entwickelte sich eine rege Aussprache.

Der Stellvertretende Bundesjugendleiter der Siebenbürgisch-Sächsischen Jugend in Deutschland (SJD), Andreas Roth, zugleich HOG-Referent der Bundesjugendleitung, stellte die SJD, die Jugendgliederung des Verbandes der

Siebenbürger Sachsen vor. Schwerpunkt der Arbeit der SJD sei es, die junge Generation an die Gemeinschaft der Siebenbürger Sachsen heranzuführen. Dies werde mit einer Mischung aus Kultur, Brauchtum und Freizeit derzeit erfolgreich praktiziert. Andreas Roth rief die Tagungsteilnehmer auf mitzuhelfen, junge Menschen aus ihrer jeweiligen HOG zu animieren, die SJD aktiv auch als Mitglieder zu unterstützen. Analog zum Landesverband Bayern des Verbandes, der für SJD-Mitglieder eine 30-prozentige Eintrittsermäßigung bei Veranstaltungen festgelegt hat, wurde dieses auch den HOGs empfohlen. Es würde auch zu einer Optimierung der Zusammenarbeit zwischen HOGs und dem Verband der Siebenbürger Sachsen und seiner Jugendgliederung führen. Eine gegenseitige Hilfe sei wünschenswert.

Der Samstagnachmittag war den Besprechungen der neun Regionalgruppen gewidmet. Anschließend wurden die wichtigsten Ergebnisse der einzelnen Regionalgruppen vorgestellt.

Am späten Nachmittag wurde der Bundesvorsitzende des Verbandes der Siebenbürger Sachsen in Deutschland, Dr. Bernd Fabritius, willkommen geheißen. Der Bundesvorsitzende war eingeladen, um über die Beitrittsmöglichkeiten des HOG-Verbandes zum Verband der Siebenbürger Sachsen zu sprechen. Die Auswertung eines Fragebogens an die HOGs präsentierte zunächst Hans Gärtner. Fazit der Umfrage: Eine stärkere Zusammenarbeit wird gewünscht. Ein Beitritt des HOG-Verbandes wird mehrheitlich gewollt, die endgültige Form muss aber noch festgelegt werden.

Dr. Bernd Fabritius wies auf die unterschiedlichen Aufgaben der beiden Verbände hin, wodurch eine Vereinnahmung des jeweils anderen gar nicht möglich sei. Der Bundesvorsitzende stellte den geplanten Rahmenbeitritt des HOG-Verbandes dar, der den kleinsten

gemeinsamen Nenner aktuell beinhalte. Wichtig für die Außenwirkung der Siebenbürger Sachsen in Deutschland sei, dass man sich in der bundesdeutschen Öffentlichkeit als eine Einheit darstelle. Hierfür sei der Beitritt des HOG-Verbandes der pragmatische Weg, da der Verband der Siebenbürger Sachsen die in Jahrzehnten gewachsenen Strukturen an den neuen Wohnorten aufweise. Es folgte eine ausführliche, teils hitzig geführte Debatte.

Der Samstagabend endete mit dem „Flecken“-Essen, das die Vertreter der Regionalgruppe Burzenland durchführten und die Regionalgruppe Harbachtal und Großschenker Raum gesponsert hatte. Der Tag klang in fröhlicher Runde mit viel Musik und Gesang aus.

Der Sonntag begann mit einer Morgenandacht, gestaltet von Bischof Reinhart Guib. Der Verbandsvorsitzende Michael Konnerth verkündete seinen vorübergehenden Amtsverzicht aus gesundheitlichen Gründen. Dankesworte für die bisherige Arbeit waren verbunden mit den besten Genesungswünschen. Die Amtsgeschäfte übernehmen bis zu Konnerths Genesung die beiden Stellvertretenden Vorsitzenden Karl-Heinz Brenndörfer und Werner Henning.

Es folgte die Abstimmung darüber, ob der HOG-Verband Beitrittsverhandlungen mit dem landsmannschaftlichen Verband führen soll. Bei 60 abgegeben Stimmen votierten 52 HOGs für Beitrittsverhandlungen, acht stimmten dagegen. Somit ist der Vorstand des HOG-Verbandes beauftragt, Beitrittsverhandlungen zu führen und bei positivem Abschluss auch den Beitritt des HOG-Verbandes durchzuführen.

Die 16. Tagung der Heimatortsgemeinschaften hat gezeigt, dass die Verbindung der Siebenbürger Sachsen in Deutschland zur Heimat Siebenbürgen hervorragend funktioniert, genauso aber auch die künftige verstärkte Zusammenarbeit der Landsleute in Deutschland erstrebenswert und möglich ist. Dies kann man aus gesamtsiebenbürgischer Sicht nur begrüßen. Wie es Bischof Guib treffend formuliert hat, sind wir alle aufeinander angewiesen. Die nächste Tagung des Verbandes der Heimatortsgemeinschaften findet vom 25. bis 27. Oktober 2013 erneut in Bad Kissingen statt.

Peter Pastior, Ehrenvorsitzender des Sozialwerks, wird 80

Der ehemalige Bundesgeschäftsführer der Landsmannschaft und heutige Ehrenvorsitzende des Sozialwerks, Peter Pastior, engagiert sich seit mehr als drei Jahrzehnten in besonderem Maße für das Schicksal seiner Landsleute in Deutschland und Siebenbürgen. Dank seines gewissenhaften, korrekten und herzlichen Wirkens genießt er ein sehr hohes Ansehen sowohl unter den Siebenbürger Sachsen als auch deren Einrichtungen.

Beim 20. Sachsentreffen am 18. September 2010 in Bistritz wurde Peter Pastior mit der Honterus-Medaille des Siebenbürgerforums ausgezeichnet. In seiner Laudatio hat Dr. Christoph Bergner, Aussiedlerbeauftragter der Bundesregierung, Peter Pastiors geistige Wurzeln einfühlsam und treffend beleuchtet. Sein vier Jahre älterer Bruder Oskar Pastior gehörte im Januar 1945 zu den 30 000 Siebenbürger Sachsen, die nach Russland verschleppt wurden. Als er ausgehoben wurde, rief ihm die Großmutter im Flur des Hauses in der Reißenfelsgasse in Hermannstadt zu: „Ich weiß, du kommst wieder!“ Diese Aussage, die die Literaturnobelpreisträgerin Herta Müller in ihrem Roman „Atemschaukel“ zitiert, ist nach Ansicht Bergners „ein Zeichen der Hoffnung, die aus dem Gefühl unauflösbarer Zugehörigkeit und Zusammengehörigkeit erwächst“. Diese berühre nicht nur den Geist der Familie Pastior, sondern wurzele bei den Siebenbürgern in einer einzigartigen Tradition der Nachbarschaften, Bruderschaften, Schwesterschaften und selbstverwalteten Solidargemeinschaften. Die Gemeinschaften lebten heute als Motive weiter und finden sich in Peter Pastiors vielseitigem Wirken wieder, betonte Bergner.

Als Sohn des Zeichenlehrers Oskar Pastior am 22. Oktober 1931 in Hermannstadt geboren, gehörte Peter Pastior einem im damaligen Rumänien an den Rand gedrängten Personenkreis an. Nach dem Bakkalaureat in Hermannstadt waren ihm weiterführende Ausbildungswege zunächst versperrt. Dennoch arbeitete er sich aus eigener Kraft vom Hilfsarbeiter in der Holzindustrie bis hin zum Buchhalter in einem staatlichen Landwirtschaftsbetrieb empor. Das Haus in der Reißenfelsgasse war auch in den Jahren des dunklen Kommunismus ein Hort warmer Häuslichkeit und Begegnungsstätte eines großen Freundeskreises, getragen von seiner Mutter Hilda und seiner Frau Dorothea.

1979 gelang es Peter Pastior mit seiner Frau und den beiden

Söhnen, nach Deutschland auszureisen. Kurz danach wurde er Bundesgeschäftsführer der Landsmannschaft, eine Stelle, in die er sich schnell einarbeitete und die er auch nach 1989 souverän koordinierte, als der „Zentrale“ in München angesichts der steigenden Mitgliederzahl immer mehr Aufgaben zuwuchsen. Sein Wissen um eine korrekte Finanzgebarung stellte Pastior auch nach seinem Rentenamtlich zur Verfügung. Seit 1994 dem Verband ehrenamtlich zur Verfügung. Seit 1995 sorgt er als Schatzmeister dafür, dass wirtschaftlich gearbeitet wird und die Haushaltsvorgaben eingehalten werden. So hat er maßgeblich bei der finanziellen Gestaltung der neuen Begegnungsstätte und Geschäftsstelle in der Münchner Karlstraße mitgewirkt, die inzwischen schuldenfrei ist.

Angesichts der konfliktträchtigen Entscheidungsfrage „Bleiben oder Gehen?“ habe sich Pastior schon als Geschäftsführer vor allen Dingen um die Frage gekümmert: „Wo können wir helfen und wo kann ich helfen“, sagte Bergner in der eingang erwähnten Laudatio. So wurde er November 1994 zum Vorsitzenden des Sozialwerks gewählt und führte die vom Gründungsvorsitzenden Willi Schiel begonnene Arbeit konsequent fort. In seiner Amtszeit von 1994 bis 2011 wurden Hilfsmaßnahmen und Projekte in Höhe von mehreren Millionen Euro in Siebenbürgen durchgeführt. Er wusste um die Belange seiner Landsleute bestens Bescheid und hat sich durch zahlreiche Spendenaufrufe dafür stark gemacht, dass ihnen geholfen wird.

Das Sozialwerk erfreut sich eines hohen Ansehens sowohl

bei der Saxonia-Stiftung als auch bei der Landeskirche und dem Forum. Hoch angesiedelt ist es auch als Mittlerorganisation des Bundesinnenministeriums und des Bundesverwaltungsamts, weil die Hilfsmaßnahmen korrekt, zuverlässig und mit geringen Verwaltungskosten abgewickelt werden.

Im März 2011 hat Pastior die Leitung des Sozialwerks aus Altersgründen abgegeben und wurde zum Ehrenvorsitzenden ernannt. Ein „besonderes Verständnis“ für die Anliegen seiner Landsleute bescheinigt ihm auch der Ehrenvorsitzende des Verbandes, Dr. Wolfgang Bonfert, der als früherer Bundesvorsitzender eng mit ihm zusammenarbeitete. Seit 2001 verwitwet, findet Peter Pastior weiterhin die Kraft und Energie, sich für das Gemeinwohl der Siebenbürger Sachsen einzusetzen. So betreut er seit Kurzem das Korrespondenzbüro, das die Michael-Schmidt-Stiftung in München eingerichtet hat. Im privaten Bereich geht er verstärkt seinem Hobby, dem Videofilmen, nach und hat dabei, in Zusammenarbeit mit Fachleuten wie Günter Czernetzky, einige sehr gute Ergebnisse erzielt.

Im Namen vieler dankbarer Landsleute gratuliert der Bundesvorsitzende Dr. Bernd Fabritius dem Jubilar und wünscht ihm Gesundheit und weiterhin viel Schaffenskraft.

Viktor Kästner: De Härwestfäddemcher

An goldenen Oktobertagen konnten wir uns zum Ende dieses Herbstes erfreuen. Dagegen dürfen wir im abgedruckten Gedicht „De Härwestfäddemcher“ den Reichtum seines Wortschatzes bewundern, der letztlich ein Reichtum seiner und unserer Mundart ist. Das Gedicht entstammt der von Adolf Schuller besorgten Ausgabe „Gedichte in siebenbürgisch-sächsischer Mundart von Viktor Kästner“, 2. Auflage, Hermannstadt 1895, S. 16-18.

Early settlers, explorers celebrated thanksgiving

At the University of Florida, historians argue that the earliest attested thanksgiving celebration, in what became the U.S., was celebrated by the Spanish on Sept. 8, 1565 in what is now St. Augustine, Fla.


Some historians say the first celebration in the U.S. was in Virginia. Thanksgiving services were held there as early as 1607.

A day of thanksgiving was codified in the founding charter of Berkeley Hundred Plantation in Charles City County, Virginia in 1619. Others say the first Thanksgiving was on Berkeley Plantation on the James River in 1609.

According to the History Network, the first celebration

in the New World may have been at San Elizario, near the present-day city of El Paso. In 1598, it was celebrated by a weary group of Spanish explorers, led by Juan de Onate, who had just completed a long trek across the Mexican desert to the banks of the Rio Grande River.

The traditional story of Thanksgiving focuses on the Pilgrims at Plymouth in their first small harvest in the autumn of 1621. Their numbers diminished by half, 53 Pilgrims celebrated their modest harvest with a company of 90 Indians. Both Pilgrims and Indians had suffered mightily during the previous winter of disease and starvation.
