BRANCH 9, CHICAGO By Rose-Marie Hauer


Greetings to everyone! Hopefully everyone has had a great summer.

I was reading some articles on Life Insurance and read the following quote: Tomorrow isn't promised to anyone, but we can plan for it. September is Life Insurance Awareness Month. It was created to highlight a national problem: too many families face financial hardship when the unexpected happens. A former pantry staple seeks a lifeline

Del Monte, the 138-yearold titan of the canned food industry, has filed for Chapter 11 bankruptcy as it struggles with pandemicera overproduction mistakes, inflation side effects, rising steel and aluminum costs, and a costly debt burden. The cash-strapped company, which also produces Contadina tomato sauces and College Inn broths, is currently seeking a buyer, but whoever those new owners are, they'll still face an unresolved existential problem: Consumers aren't buying canned food like they used to.

The past five decades haven't been kind to the canned food industry. According to the United States Department of Agriculture, 30 percent of vegetables and 11 percent of fruits available for consumption in 1970 were canned. These days, canned vegetables account for just 23 percent of available vegetables, and canned fruit has dropped to a puny 5 percent.

According to the New York Times, consumers to-day are more likely to opt for fresh options over canned, and grocery budgets are tighter than ever, thanks to higher retail prices -- about 30 percent higher on average than just three years ago and still climbing. When consumers do choose canned foods, they're more likely to buy store brand options, which are typically priced below name brands.

chase the bare minimum of life insurance that is available to get them membership in the ATS. We need to do better for them. A \$3,000 or \$5,000 policy today will not go very far in the future when that child is an adult with a family. Keep in mind that the average cost of a funeral today is \$7,000 to \$10,000. Remember, life insurance isn't about you - it's about the people you love most. An adequate amount of life insurance will ensure that no matter what happens to you in the future, their financial future is protected.

Did you know that the first drunk driving arrest occurred on September 10, 1897? A 25-year-old taxi driver in London was the first person ever arrested for drunk driving after his cab slammed into a building. George Smith later pleaded guilty and was fined 25 shillings. According to History.com, the first laws in the United States against operating a motor vehicle while under the influence of alcohol went into effect in New York in 1910. With the surge in automobile ownership during the 1920s, other states followed suit. With the repeal of Prohibition in 1933, alcohol availability increased even more. The first device to measure intoxication was developed and patented by Dr. Rolla Harger, a professor of biochemistry and toxicology from Indiana. He created the "Drunkometer", a balloon-like device into which people would breathe to determine whether they

were inebriated in 1936. In 1953, Robert Borkenstein, a former Indiana state police captain and professor who had collaborated with Harger, invented the Breathalyzer. This device was easier to use and more accurate than the Drunkometer. It was the first practical device and scientific test available to police officers. A person blows into the Breathalyzer, and it gauges the proportion of alcohol vapors in the exhaled breath, reflecting the level of alcohol in the person's blood.

Even with this newer and easier to use invention, it was not until the late 1970s and early 1980s that public awareness about the dangers of drinking and driving increased, and lawmakers and police began to get tougher on offenders. In 1980, a California woman named Candy Lightner founded Mothers Against Drunk Drivers, known as MADD, after her 13-yearold daughter was killed while walking home from a school carnival. The drunk driver had three previous convictions for drunk driving and was out on bail from a hit-and-run arrest two days earlier. Lightner and MADD were instrumental in helping to change attitudes about drunk driving and pushed for legislation that increased penalties for driving under the influence of alcohol and/or drugs.

I hope everyone enjoys this Oktoberfest season; just do so responsibly, please!

SAXON LIFE OF MICHAEL FARR

(his story is paraphrased from excerpts of his story)

Michael Farr was born March 2, 1888, in Weilau, Transylvania. At the time, this was part of the Austro-Hungarian Empire. Michael father's name was George and mother's name was Susanna (maiden Tinnes). Michael had an older sister and brother, and a younger brother and sister.

When he was four years old the family house burned down in 1892. All they had left from the house was the clothing on their backs. Much of their livestock that was in the field at the time, so they were fine. However, they had some livestock (a cow and some pigs that they couldn't get out of the stable in time so, they lost them. Michael's family was poor, so his father had to go to the bank to borrow money in order to rebuild their family home. They were forced to live in the basement until his father returned from Sus Regan with wood and supplies to rebuild their home.

Like many hard-working Saxon families everyone had duties and responsibilities. At

six years old Michael started school. The school day was long, and he would study by an oil lamp in the evenings. When he came home from school, he would cut wood and clean the stables until dark. In the summer his routine would change. He would only attend school until noon, and in the afternoons, he would work in the fields hoeing corn. His father and older brother would plow the fields, and in the afternoon his older brother would help him hoe corn. It was hard work, and he worked hard to show his father how much he could do. His father appreciated the effort and told he had done "A big piece," by all that he had done.

When Michael was thirteen, he was hired out to George Moser for the summer. In the winter he would go to school. Michael had to sleep in the stable at night. At first, he was afraid that something was going to take him away in the night. Eventually, he got used to the solitude and it was fine.

At fourteen, Michael was hired out for fourteen gulden (about \$5-6 dollars a year). His job was to mow the grass with a scythe. It was definitely hard work. A gentleman came by and said the boss's wife said Michael was too young to be mowing. After some discussion, it was decided that if he was getting paid fourteen gulden, then he should be able to do the work.

When Michael was fifteen, he was hired out to Johann Gross. The Gross family were relatives. While staying with them he would get confirmed. While he was working for the Gross family, his uncle (Johann's brotherin-law), saw how hard he worked and said, "Michael, I want you to come work for me and I will give you more money." Because Michael





ATS OPEN BOWLING **TOURNAMENT RULES**

- All bowlers must be Alliance of 1. Transylvanian Saxon members in good standing to participate in this tournament.
- 2. Each bowler will receive 100% of the difference between his or her average and a two hundred ten (210) scratch with no limit on pins.
- 3. Averages to be used are:
 - The average of the past five years' tournaments, with exception of 2020.
 - If the bowler has no tournament b. average, then the bowler will establish his or her average after the first three games rolled in the tournament, which will remain the bowler's average for the remainder of the tournament.
 - If a team has a blind, then a 200 c. Average is used and no handicap.
- A bowler may only bowl once in each 4. event in this tournament.
- The tournament management has the right 5. to return for correction any entry which does not comply with the above rules.
- Prizes will be awarded at the ratio of at 6. least one (1) prize for each ten entries. One hundred percent (100%) of the prize fee must be returned. Prizes will be awarded by handicapped scores and not by gender.
- It shall be the duty of the tournament 7. manager to keep a running record of all bowlers' averages participating in each event.
- 8. Tournament starts on October 18, 2025 and ends on October 19, 2025.
- 9. Closing date for entries is October 1, 2025.
- 10. There will be no refunds of fees after October 10, 2025.
- 11. Two All Events Winners will be awarded. One for actual scores; one for actual scores plus handicap.
- We will start with Doubles Event followed 12. by the Singles Event on Saturday.

Your All Events score will be your total individual score of singles, doubles, and team event plus your handicap total for the tournament.

Separate men and women prizes will be awarded in Singles event only. Doubles and team event will be mixed.



How were glasses invented, anyway?

It's difficult for us to imagine, but before glasses existed or were available to anyone except the very wealthy, a huge number of people just couldn't see very well.

According to Urban Optiks, our nearsighted ancestors simply had to rely on their other senses to see far away objects. Our farsighted ancestors were forced to squint at things or bringing them very close to their faces. Historical depictions of scribes often reflect this, showing them stooping over their desks with noses almost brushing the papers.

But eventually, glasses did come along near the end of the 13th century. According to National Public Radio, the first known eyeglasses came from northern Italy, an area known for its glass production. Spectacles soon became a luxury item, and records show that merchants often carried them along the Silk Road to Asia, where they turned into a status symbol and occasionally a mandatory accessory for China's vaunted class of civil servants.

Those early glasses, with heavy frames (which tied to the head) and shatter-prone glass or quartz lenses, weren't an ideal solution. The first glasses were solely intended as readers, and the first spectacles for near-sightedness didn't show up until the 15th century.

Interestingly, as literacy and book reading became more common, and requiring good close-up vision, distance vision deteriorated. This is possibly because of eye adaptation, but the correlation has been noted for centuries.

During the Reformation, when literacy rates surged and nearsightedness became a common affliction, glasses became more accepted. Even so, purchasing glasses just involved trying on different pairs until you found one that seemed to work. Eye charts, eye exams, and standard lenses didn't come along until the 19th century.

Today, glasses are not only mainstream, but actually considered fashion statements. We don't even need to tie them to our heads, but that could come back.

How to spot a crypto scam

Cryptocurrency may have begun as an obscure digital experiment, but these days it's a mainstream investment.

According to Security.org, around 65 million American adults own cryptocurrencies, and two-thirds of people who already own cryptocurrencies intend to keep building their stockpiles. But some of the things that make it popular -- decentralization, privacy, and limited government oversight -- make it a lucrative business for scammers.

If you own cryptocurrency or are interested in purchasing some, watch out for some of these major red flags:

- Demands for payment in cryptocurrency. If you receive a demand for payment in cryptocurrency, especially in advance, don't pay. A legitimate business, government agency, or brokerage will never even ask. Investment scams. An "investment manager" might contact you with an irresistible one-time opportunity that requires an up-front payment with crypto, and they might even have a website with an "investment account," but it's all sleight of hand while they take your money and run.
- Online dating scams. Even modern technology isn't immune to a classic romance scam. If someone charms you on Bumble and then tries to ask you for a cryptocurrency payment or if you'd like to invest, it's a scam.



- Celebrity scams. One man lost \$10,000 after an AI-generated Elon Musk talked him into a fake crypto investment, complete with a fake website that showed his investment growing to \$50,000, according to DigWatch. Be wary of any celebrity-endorsed cryptocurrency investments, and remember that Brad Pitt will never, ever contact you personally to ask for Bitcoin.
- Corporate impersonators. Fraudsters will pose as big companies like Amazon or FedEx in calls, emails, and text messages to warn you about cybersecurity risks, bank fraud, or other potentially serious problems -- and then request a cryptocurrency payment to resolve the issue.

Even King Arthur's knights wore hard hats

Today, hard hats are worn by workers in many types of jobs. They are also worn by football players, soldiers and bike riders. Whether for work or play, they have an essential role in safety.

It's not a new concept.

King Arthur's knights in shining armor wore metal helmets to protect their heads. Ancient drawings depict people in head-protecting hats in the ancient civilizations of China, Egypt, Greece and Rome.

The first protective hats made by E.W. Bullard Company, a mining equipment maker, were made of leather. When Bullard's son returned from the First World War with a steel helmet, that changed.

In more modern times, when famous writer Franz Kafka was with Workers Accident Insurance in Bohemia, he was instrumental in developing the protection hat in 1912, according to legendary management icon Peter Drucker.

In the 1933 construction of the Golden Gate Bridge, all workers had to wear safety helmets. Bullard also designed a helmet for sandblasters with a shield in front, like a window, and a hose for breathing.

In 1938, the first aluminum hard hats were made. They were very durable and fairly lightweight. These hats had one serious drawback: aluminum is a great conductor of electricity.

In the 1950s and 1960s, thermoplastics became the newer material. Manufacturers injected thermoplastic into a mold to produce a hard hat.

Helmets are now made of a high density plastic. They have features like earmuffs, extra ventilation, face-shields, sun visors, linings for absorbing sweat and extra attachments like pagers, radio, cameras or walkie-talkies.

PROPOSED CHANGES TO NEW CASTLE BRANCH 25 CONSTITUTION

Constitution **Article III Membership**

Section 2.

Applicants for Active membership in this society have voting rights. They must be male, 21 or more fying by one of the three criteria below:

- 1. Is of Transylvanian Saxon or German birth or a descendant thereof.
- 2. Is married to someone of Saxon or German birth legally. or a descendant thereof.
- 3. If other than the above the applicant must agree to the next monthly meeting's business. to support the preservation of the ethnic and cultural goals outlined in the national Alliance Constitution and By-Laws.

And must also qualify by one of the two criteria below:

1. Is an owner of an Alliance life insurance policy or an Annuity contract.

2. Is an existing member and over the age of 50 when this revision of the constitution was adopted.

And must also be the owner of an Alliance life insurance policy or an Annuity contract. Existing Active members over the age of 50 when this revision of the constitution was adopted on September 12, 2024, do Not need to purchase an Alliance life insurance policy or an Annuity contract.

Active Membership privileges begin when a national alliance policy is approved.

Members who surrender their ATS National Alliance policy cannot remain Active members.

Section 3. Only active male members are entitled to vote, but all male members have the right to join the Singing Section.

b. All Delegates must be in good standing, that is, they must be fully current with all payments to the Alliance and the Branch 25 as of December 31, preceding the Convention.

Section 2. The Society must forward the name and certificate number of its Delegates on certified official forms to the Alliance Home Office by April 15, preceding the Convention.

Section 3. Any <u>National</u> Alliance member in good standing, regardless of ancestry or affinity, may be elected or serve as a Delegate.

Section 4. The President and ATS Secretary shall automatically be the first two Delegates and remaining Delegates shall be elected.

was such a good worker he would get hired on at sixteen and seventeen years old for his Uncle Schmidt. His uncle was extremely nice to Michael and treated him well. He would always ask Michael, "What are you going to do tomorrow", meaning what are you going to do with your life, it's up to you. His uncle would tell him if you go out in the evenings with the boys and have a beer, when you come home, no matter what time it is, feel free to come into the house and slice some bread and eat; don't go hungry. The only problem was that he couldn't get along with his aunt. She would complain about him and Michael decided he couldn't stay for another year.

This time, instead of being hired out, Michael hired himself out; he found his own job. He got a job working on a farm that had horses and oxen. This did not go over well with his uncle. He told Michael, "You are not a horseman or oxen Knecht (boy-meaning you don't do that type of work). After a heated discussion, my uncle told one of his helpers to take my gulden back to Fritsch. Fritsch wouldn't take it back at first, and then my uncle said you go back and put the money on the table and walk out. His helper did that.

After that, my uncle hired me out to another rich person. Schuller had a dozen oxen, cows and horses. Poor Michael got caught in the middle again. This became a family feud because they were related. Fritsch accused Schuller of hiring his man away. Because they were related, Schuller said he didn't want any trouble with his family, so Michael was out of a job.

So, Michael was hired out again, to another rich person, who was a judge. They had a lot of livestock. Michael had always been a hard worker, but he soon learned how backbreaking work could be. Michael had to clean the stable every morning, and in the afternoon, carry the manure about 100 feet, with a basket in front of him to the manure pile. Then he would clean 20 animals every day. Michael was working from 2:00 a.m. to 10:00 p.m. Even though they were rich they served him terrible meals, and he was basically served the scraps that were left-overs. The family had a huge storage of wine, probably 2,000 gallons in their basement. They never offered any wine to Michael. The judge had a son and daughter-in-law that were nice to Michael would sneak him wine but they knew the judge was the boss so they couldn't help that much. The work never ended. Local news goes dark

What is your local city council doing this month? Are they changing zoning? Raising taxes? What is your school district doing? Chances are increasingly good that you don't know and you won't know.

Since 2005, about one-third of local newspapers have disappeared, creating new deserts where politicians and bureaucrats operate without any oversight. An average of 2.5 newspapers closed each week in 2023.

According to Journalism & Mass Communication Quarterly, part of the reason is commerce. Since online shopping became mainstream, local retail stores, large and small, have disappeared, leaving no commercial advertising base that once supported newspapers.

What happens is that local governments become less accountable, as lack of scrutiny declines or even disappears.

In fact, the smaller the community the more likely that citizens get their news from Facebook or other social media, suggesting an opportunity for citizen journalists. According to Pew Research, 52 percent of U.S. adults say they get local news from social media or radio stations. A third of Americans say they sometimes get local news from a daily newspaper.
